Universal Credit – please update your new rent charge

Just to remind all tenants that our new rent charge came into effect on 18 March 2019. If you receive Universal Credit it is important that you inform them of your rent increase as soon as possible, and preferably within your monthly assessment period, otherwise you risk losing out on the increase. This notification should be completed on line through your Universal Credit on-line account. Incapacity Benefit - did you move from Incapacity Benefit to Employment & Support Allowance between 2011 and 2014?

The DWP have accepted they made mistakes in many cases when moving claimants from Incapacity Benefit to Employment & Support Allowance. This meant thousands of people were underpaid. Many people have already

been contacted by DWP about this and many have received backdated payments. If you think you might be affected please contact us for advice.

Appeals - do you think your decision is wrong? always get advice !

New Ministry of Justice statistics show that Social Security appeals found in favour of claimants have increased to 74% for Employment & Support Allowance (ESA) and 73% for Personal Independence Payments so if you've had a decision you're not happy with please contact us for assistance.

Changes to benefit rules from 15 May 2019 – 'mixed age couples'

These changes will affect couples where one has reached pension credit age and the other is younger and still of working age. All couples who fall into this category should have received a letter from DWP setting out the details however if you are concerned by these changes or whether they might affect you please contact us for assistance.

Students

Claiming benefits when a course ends

When you finish a full-time course you no longer count as a student for benefit purposes, and can therefore claim benefits in the same way as anyone else. The date you can claim from is usually the day after the last day of the final academic year of your course.

Universal credit

If you need to claim a benefit which has been replaced by universal credit (UC), for example Jobseekers Allowance, you must usually claim UC. A claim for UC begins with an 'assessment period' of one month, and the rules specify that you do not count as a student in the assessment period in which your course ends. This means you should be able to claim UC from around 4 weeks before the end of your course. Claim online at www.gov.uk/apply-universal-credit. Payment is usually made a week after the assessment period ends. This means it is usually at least five weeks from claiming UC to being paid. If you are in hardship while waiting for your first UC payment you can ask for a short-term advance. However this is repayable from your UC award.

Note also that your student income is not counted as income in the assessment period' in which your course ends.

Example

Claire's course ends on 7 June 2019. She claims UC on Monday 13 May. Her first assessment period runs from 13 May to 12 June. She leaves her course as expected on 7 June and therefore is no longer a student for UC, and her student loan is no longer taken into account as income. Her first payment is made on 20 June, and she receives her maximum UC amount on this date as no student income is counted.

As well as UC you should claim council tax reduction from the local authority to reduce your council tax bill.

Planned Works

We have been working hard on delivering much demanded improvements to the • 120 houses with new windows houses through the introduction of new kitchens, new bathrooms, new gas boilers, upgrades to door entry systems and repainting works.

The works being carried out represent an investment of approximately £1.5m by the Association in the housing stock. From the 1st April 2018 through to the end of March the Association will have completed the following:

Fly Tipping Around Ferguslie Park

Fly tipping is a serious issue, which FPHA and our partners are determined to help stamp out. We know this concerns our tenants and we are working hard to tackle the problem.

Getting rid of rubbish without permission to do so or keeping or disposing of any hazardous waste in a way likely to cause pollution of the environment or harm to human health are classed as fly tipping and an offence under the Environmental Protection Act 1990.

Anyone found to be fly-tipping can be given a Fixed Penalty Notice of £200 and this may be more depending on what has been dumped or if the case goes to court.

We are working with the Rapid Response Team at Renfrewshire Council as well as the Environmental Training and Community Pay Back Teams. Together we are trying and make Ferguslie Park a better place to live and a more pleasant environment for all.

We cannot do this without support in your area and need you to help. You can do this by reporting any flytipping you see or anyone disposing of rubbish in the area either directly to the Association or to Renfrewshire Council by calling 0300 300 0300 or by clicking on the "Report Flytipping" tab on the Council's Team Up to Clean Up page. Please also report abandoned supermarket trolleys.

Remember that if you have larger items you wish to dispose of we can uplift these free of charge.


Kids Easter Competition
