A word from our Welfare Rights Team Moving to Universal Credit Update

Universal Credit (UC) is a benefit that will eventually replace most 'working age' benefits.

Claimants who receive Tax Credits, (Income Related) Employment & Support Allowance, (Income Based)

Jobseekers Allowance, Income Support and Housing Benefit (these are known as Legacy Benefits)

will be moved from their legacy benefit over to UC. This process is known as 'Managed Migration'.

Managed Migration

From April 2024 the DWP may, at any time, issue 'some' claimants with a 'migration notice' to notify them that their existing benefits will be ending and they need to claim UC before a specific deadline day, the deadline day is three months from the date of the notice. It is expected that claimants, who have not applied, should receive a reminder letter 7 weeks after the migration notice and a final reminder by text or letter one week before the deadline day.

Termination of Existing Benefits

The notified person can claim UC at any time before the deadline day. UC entitlement will usually start on the date the claim is made and 'legacy benefits' will be terminated – tax credits from the day before the start of the UC claim, and other legacy benefits two weeks later. If the notified person does not make a UC claim by the deadline day, legacy benefits will be terminated – tax credits from the day before the deadline day and other legacy benefits two weeks later.

Transitional Protection

The government pledged that no-one would be worse off as a result of managed migration, at the

point of transfer, if circumstances are unchanged, however it's extremely important to make the UC claim on or before the deadline date provided, otherwise there is a risk of losing 'transitional protection' and becoming worse off.

It's not possible to provide a specific date when claimants will be notified however the DWP have said it is being rolled out by benefit type, with tax credit only claimants being the first to be affected in 2023/24 (this group is expected to have transferred over by end of March 2024) and claimants who receive (Income Related) ESA only and (Income Related) plus Housing Benefit only being the last group to transfer over in 2028/29.

The expected timetable Migration is as follows;

- 2023/24 claimants on Tax Credits (TCs) Only
- 2024/25 claimants on TCs 'and', (ir)ESA, ibJSA, IS, HB
- 2024/25 claimants on ibJSA, IS, HB
- 2028/29 claimants on irESA, 'and' irESA plus HB

If you would like to know how this change is likely to affect you please contact Robert or Ian from our Welfare Rights Team or if you need help to make the claim when the times comes please contact us to arrange a suitable appointment.

Your bins...

Grey bin

Your grey bin is for rubbish that cannot be recycled, also called 'general waste'.

These items can go in your grey bin:

- non-recyclable waste
- plastic bags
- polystyrene or foam packing
- crisp and sweet wrappers
- used tissues and paper towels
- cling film, tinfoil
- lightbulbs
- pet litter
- nappies
- personal hygiene products
 (such as tampons, incontinence products, and baby wipes)
- food and drinks pouches
- hard plastics (such as toys, coat hangers, or CD cases)
- envelopes with interior padding, such as bubble wrap shredded paper.

Blue bin

Your blue bin is for paper and cardboard.

These items can go in your blue bin:

- cardboard (flatten it so it's easier to collect)
- cereal boxes
- toilet and kitchen roll tubes
- paper (as long as it's clean and dry)
- envelopes (it's okay to leave the clear, plastic window on them)
- magazines
- newspapers
- office paper
- telephone directories
- paperback books
- catalogues
- junk mail and takeaway menus.

Green bin

Your green bin is for plastics, cans, and glass.

These items can go in your green bin:

- plastic bottles, milk cartons
- plastic pots, tubs, and trays
- plastic fruit and vegetable trays
- plastic takeaway containers (emptied and rinsed)
- cleaning product bottles
- shampoo and shower gel bottles
- drinks cans (emptied and rinsed)
- food tins, including pet food tins (emptied and rinsed)
- biscuit and sweet tins
- aerosols
- glass bottles and jars.

Brown bin

Your brown bin is for garden waste and food waste. You need to buy a garden waste permit (www.renfrewshire.gov.uk/article/3745/garden-waste) before you can put garden waste in your brown bin.

These items can go in your brown bin:

- grass cuttings
- flowers and plants
- weeds
- leaves
- branches and twigs (small enough to fit in the bin with the lid closed)
- cooked and uncooked food
- fruit and vegetable peelings
- tea bags and coffee grounds
- eggshells
- out-of-date food (all packaging removed)
- meat, fish, and small bones.

Planned works to homes

New Windows & Doors

We are close to issuing a tender to appoint a contractor to replace windows and doors in during the summer months. We have identified 112 houses that are due to get the installation of new windows and/or doors and the Association's board have decided to invest around £750,000 for replacement in 2024.

It's expected that we should be starting these works during the summer months and those tenants that are part of this programme have been sent a letter by our Property Asset Assistant, Suzanne Davidson. In addition to the houses that are part of this phase we are also looking to continue to replace the windows and doors in more houses through 2025.

New Boilers

We are also starting a small programme to replace older boilers with high efficiency modern boilers.

This programme is an investment of around £35,000 and it means that all homes have had boiler upgrades in recent years.

We do however have one eye on the future and are investigating options for replacing boilers in years to come with more carbon neutral heating appliances to help reduce carbon emissions from homes.

New Kitchens

In our last newsletter we highlighted that we are aware of some kitchens installed in 2010 to 2013 where some the units were failing due to an issue we are calling delamination where the face of the units are peeling away. We'd like to thank tenants who have reported these kitchens to us.

The Association's board has recognised this issue and also the need to replace other kitchens which have reached the end of their life. A budget of around £550,000 has been created for the replacement of kitchens in 2024. We are going through the necessary work to tender the contract and appoint a contractor to undertake this programme of works.

Other Works

We are working through a small programme of replacing fences in the estate and intend to start a programme of painter work of metal fencing throughout the estate and also gutter cleaning. Tenants will be contacted in advance of when these works will be carried out.

Grounds Maintenance

Keeping on the garden theme mentioned earlier we will also be starting our grass cutting for open spaces and also tenants who are part of our garden tidy scheme.

We are continuing to work with our contractor In-Work Enterprises whom we had positive

feedback on their performance in 2023. In-Work are a Social Enterprise which makes them different from other contractors as they use any profits to help invest in people who have experienced mental health issues as well as young people who have been long-term unemployed.

Over the winter period our Senior Property Officer, Gavin McFarlane, has worked with In-Work to make some improvements to open spaces of grass. Some of you will see some more areas of planted trees; shrubs; flowers and wild flowers in different parts of Ferguslie to help brighten up spaces.

Gas and Electrical Servicing

Our Property Team would also like to thank tenants for helping us by allowing access to your home for your annual gas service and the five yearly check we have to do to the electrics in your home.

We are seeing a high rate of tenants giving us access and we do appreciate this. Carrying out checks to your Gas and Electrical safety is something that the Association has to do by law as well as keeping you and those in your home safe.

We do realise that it can be an inconvenience to you to make the time to allow access and to recognise this we have a monthly prize draw for those tenants who give our contractors access to your home at the arranged visit. To be in with a chance of winning the prize draw all you need to do is allow access when the contractor arranges a visit.

We do make several attempts to gain access to homes and unfortunately on some isolated occasions we have to consider forcing access. This is the last thing we want to have to do. If your visit doesn't suit you we are flexible and will always look to find a time that suits, just call us at the office on **0141 887 4053 (option 1)** and we will be happy to help.


