Thank you for bearing with us!

In 2020 the Association commenced a 3-year programme of Kitchen, Bathroom and Boiler replacements with L&D Plumbing and Heating Services ltd, unfortunately in February of this year the contractor stopped trading and works were halted.

This was extremely disappointing for the Association and tenants alike, as we were close to completing the first 2 years of the programme works and had enjoyed a good working relationship with L&D over several years.

The Assets team would like to sincerely thank those tenants affected by the unavoidable termination of the contract and for their continued support as we look to complete the programme with Saltire Facilities Management Ltd in August. In the Autumn, the Association will re-tender the remaining works to complete an additional; 38 Bathrooms, 92 Kitchens and 20 new Boiler installs, between March and July of 2023. We will also appoint an independent surveyor to complete a new Stock Condition Survey which will inform our investment plan for the next 5-year cycle.

Due to the continued price fluctuations as a result of the pandemic and other world events, the Assets team plan to complete more of the planned investment programme in the next financial year when prices have stabilised. As such we intend deferring the Window and Door Replacement programme planned for this year to next, as well as expanding the list, to include more addresses. All of those homes affected will receive a letter in the coming weeks advising of this.

We recognise that record energy prices are just one of a range of cost of living pressures that many people are facing. Given the increased proportion of income that energy bills are



likely to represent in the coming months (more increases expected in October 2022), it is now more important than ever to make sure you are receiving all the financial assistance that's available to you.

In response to the soaring energy bills the UK Government announced a package of support. Every household should receive at least £400 which should be paid automatically to the energy supplier. If you pay by direct debit the money should be credited to your account over a six month period starting in October 2022. People on pre-payment meters should have their account credited or paid by a voucher.

People on 'means tested' benefits such as Universal Credit, Income Support, Employment & Support Allowance, Pension Credit etc should also receive an additional £650 (payable in two lump sum payments) and these payments should be sent straight into the relevant bank accounts.

Pensioner households should also receive an extra cost of living payment of £300 which is payable as well as any help you may already receive for winter fuel costs.

Further payments of £150 are to be paid to certain individuals who receive disability benefits.

There is no need to fill in any forms or make any sort of applications for any of the above and payments should be paid into the accounts that are already set up.

There are a range of benefits and grants available to certain households (although certain criteria is required to qualify) from the Scottish Government and I have listed some of these below:

- Best start grants/Pregnancy & baby payments
- Free school meals/Clothing grants
- School age payments (one off payment of £267.65 if you receive tax credits or other certain benefits with children born between 01 March 2017 and 28 February 2018
- Scottish Child Payment (£20 per week to qualifying parents for each child under 6 years old). It is expected to be rolled out to include children under the age of 16 by the end of 2022 and its expected to rise to £25 per week per child;
- Child Winter Heating payments of £200 for families with a severely disabled child;

There is also the Carers' supplement and Young Carer Grant available to provide support for Carers.

Most of the above require applications so please contact our welfare rights team who are on hand to provide advice and support if you would like further information or help to claim. Or if you would like a general benefit health check, please do not hesitate to contact us and make sure you do not lose out.

In on the ground flora!

ERZ will have a stall at the NTC Gala Day on the 13th August, which will there after travel around the estate day by day to capture as may voices as possible. There will activities and information available each day for a range of ages, so everyone is encouraged to get involved! The study will cover a whole range of topics such as garden layouts, flood management, community gardens, open spaces, street furniture, bins/waste management and much, much more, but we need your views!

Complaints

We are reporting our Scottish Public Services Ombudsman (SPSO) complaints received for April to June 2022.

What is a SPSO complaint?

Ferguslie Park Housing Associations definition of a complaint is: 'an expression of dissatisfaction by one or more members of the public about our action or lack of

action, or about the standard of service provided by or on behalf of Ferguslie Park Housing Association.'

A complaint may relate to the following, but is not restricted to this list:

- failure or refusal to provide a service
- inadequate quality or standard of service, or an unreasonable delay in providing a service
- delays in responding to enquiries or requests
- unfairness, bias or prejudice in service delivery
- lack of provision, or the provision of misleading, unsuitable or incorrect advice or information
- a repair that has not been carried out properly or in an agreed timeframe
- dissatisfaction with one of our policies or its impact
 on the individual
- failure to properly apply law, procedure or guidance when delivering services
- failure to follow the appropriate process, treatment by or attitude of a member of staff or contractor (**except** where there are arrangements in place for the contractor to handle the complaint themselves) or
- disagreement with a decision.

A complaint is not:

• a routine first-time request for a service

- a request for compensation only
- issues that are in court or have already been heard by a court or a tribunal

- disagreement with a decision where there is a statutory procedure for challenging that decision (such as for freedom of information and subject access requests), or an established appeals process followed throughout the sector
- a request for information under the Data Protection or Freedom of Information (Scotland) Acts
- a grievance by a staff member or a grievance relating to employment or staff recruitment
- a concern raised internally by a member of staff (which was not about a service they received, such as a whistleblowing concern)
 - a concern about a child or an adult's safety
 - an attempt to reopen a previously concluded complaint or to have a complaint reconsidered where we have already given our final decision

abuse or unsubstantiat<mark>ed</mark> allegations about our

organisation or staff where such actions would be covered by our Unacceptable Actions Policy (or equivalent); or

 a concern about the actions or service of a different organisation, where we are not involved in the issue (except where the other organisation is delivering services on our behalf).

Below is a table detailing the SPSO complaints we have received for each department, and if the complaint has been upheld, or not upheld.

Any complaint that is upheld will be reviewed by the relevant department Manager and any improvement plans required will be implemented.

It means the investments we make over the next decade will significantly reduce your energy bills and save you money! Housing plays a big part in addressing the Global Climate Emergency and we are keen to be part of the solution whilst focusing on enhancing the lives of our tenants in everything we do.
